About the project

It is no secret that we are still facing something very young and rejected by much of today's international politics, but that only means one thing: **Opportunity** to make money.

For this reason, we have decided to take advantage of the fact that we are at the beginning of what will be a massive adoption at an international level, to create a token based in medical cannabis, that grants utility in the real world with such high potential and that rewards as no other asset in the world.



International News

The medical cannabis market is growing at a CAGR of 24.5%

According to data analyzed by Data Bridge Market Research, this market is expected to reach USD 19,153.13 million by 2028.



Derived from Cannabis

The cannabis derivative CBD already moves 2,000 million dollars in the US: Nestlé joins this fever and it is expected to reach 20,000 million in 2025, according to the specialist cannabis consultant BDSA.

New Agreements

One of the world's largest health and nutrition multinationals, Royal DSM, for example, has led a \$32 million funding round into Brains Bioceutical, a firm that produces CBD for pharmaceutical use. Similarly, British American Tobacco, for its part, has led a \$25 million investment in Trait Biosciences, a technology startup that is studying how to introduce this component into food and beverages. It has also invested \$75 million in Organigram, a company from Canada, the main producing country in the world. This operation will allow you to distribute CBD-derived products throughout the United States.

Costa Rica legalizes the production and consumption of medicinal cannabis

Costa Rica finally approved the law that regulates the production, industrialization and commercialization of hemp and medicinal cannabis after a long debate between Congress and the Government. The measure, applauded by patients, is also expected to contribute to the economic reactivation of the country.



What is a **NTT**?




Token NTT

Own real life value in the crypto world thanks to NTTs

Until now, the most used tokens (NFT and FT) had the common characteristic that they could change owners, either through direct transmission between users or through trading in a market.

This is not possible with a NTT token. This type of token, once created by its author and delivered to its owner, can no longer be transferred to another owner or sold on a market.

This type of token can be used to distribute user licenses or products that are not intended to be resold.



How the platform works



ANALYZE

Analyze the different exclusive NTT collections that we offer on our platform

BUY

Acquire the NTT that best suits your needs and observe the different yields that it will give you over time

HOLD

Sit back and enjoy watching your NTT increase in value over time as you receive USDT rewards. All this with the peace of mind of knowing that your investment will never decay

SELL...?

Once any of our investment cycles is over, you can decide if you prefer to reinvest the NTT or sell it with its increase in acquired value

Yields + Tokenomics

The NTT's, as they do not fluctuate in price, will always be bought and sold directly from our contract **for the same acquisition price + the interest that your token has generated when it is revalued by HOLDING.**

The sale of the NTT will have a decreasing tax according to the sales cycle (see page 11).



It is obvious that there will be much more advantageous collections than others depending on your interests, so you have to play your cards right when allocating your capital.

It all depends on your criteria and patience when accepting your investment.

Tokenomics

Theory

What better than an example to demonstrate the mechanism of Green Medical.

1 NFT with 4-month cycles will guarantee a quarterly return of 33%.

25% will be destined for the **HOLDERS**, paying 17% in **USDT** and the other 8% giving greater value to the **NTT** and generating **compound interest**, having the advantage of receiving higher returns in each cycle and making it really beneficial for people who are willing to **HOLD** long term.

There will be a **percentage of what has been agreed with our partners (2%)**, which will go to the team's wallet and 6% to marketing

NTTs will have a fixed "limit value", (regardless of the price of the NTT and the collection to which it belongs) reaching its goal in the tenth cycle. When that moment comes, the NTT will automatically sell and receive the entire revaluation in **USDT**.

The only variable tax that is written in the contracts is a decreasing percentage on the sale of the NTT, which will only affect the revaluation of the token, this means that you will **only be charged a tax on the increase in value of the token** and your initial investment always will be guaranteed. So the longer you **HOLD** before selling your NTT's, less taxes the contract will charge. If you add to this that your NTT will be worth more with each cycle that finishes... are you really not going to **HOLD**?

Summary of tokenomics

Team

2% of the ROI will be used to pay the team and 6% for marketing



Community

Revaluation of the NTT

The NTT will appreciate in value thanks to the rewards and the compound interest made in each cycle(8%).



Rewards

25% of the ROI will go to the HOLDERS, granting 17% in USDT and another 8% increasing the value of the NTT in possession for the following cycles.



Purchase tax

When buying the NTT, a 5% tax will be charged, which will go to the marketing wallet.



Sales tax

When selling the NTT, a tax will be charged based on the net profits that it has accumulated (see page 11). This tax will go to marketing wallet.
